Two-Button Slippers

Product Code 871035, Page Number 11

(7/19/11-sb/mjl)

SLIPPER

Make 2.

HEEL

Row 1: Sk first 6 sts on last row of Sole, join dec in next 2 sts, sl st in next st, leaving rem sts unworked, turn.

Kimono Slippers

Product Code 871035, Page Number 2

(7/16/10-st/mjl)

LEFT SLIPPER (page 3)

SIDES

Row 1: Working in **back lps** (*see Stitch Guide*), **sk 11 sc at front of toe** (*see Pattern Notes*), join light pink with sc in next st, sc in each st across to first sk sts, sl st in **front lp** (*see Stitch Guide*) of next st **at front of toe**, leaving rem sts unworked, turn.

Row 2: Ch 1, sc in same st, sc in both lps of each st across to opposite side, sc in front lp of next sk sc at front of toe, **sl st in front lp of next sk st at front of toe**, turn.

Rows 3-6: Rep row 2.

Rows 7-11: Ch 1, sc in same st, sc in both lps of each st across to opposite side, sc in rem lp of next sc at front of toe, sl st in rem lp of next sc at front of toe, turn. At end of last row, fasten off.

RIGHT SLIPPER

SIDES

Row 1: Working in back lps, **sk 11 sc to right of join at front of toe** (*see Pattern Notes*), join light pink with sc in next st, sc in each st across **to sk sts**, sl st in back lp of next st **at front of toe**, leaving the rem sc unworked, turn.

Row 2: Ch 1, sc in same st, sc in **both lps of** each st across to opposite side, sc in back lp of next sk sc at front of toe, **sl st in back lp of next sk sc at front of toe**, turn.

Rows 3-6: Rep row 2.

Rows 7-11: Rep rows 7-11 of Left Slipper.

Side-Button Boots

Product Code 871035, Page Number 8

(7/16/10-sb/mjl)

RIGHT FOOT (page 9)

SIDES

Row 1: Mark center 24 [28, 32, 36] sc at front of toe, join tan in next sc after last marked st on right-hand side of Sole, **ch 2** (see *Pattern Notes*), dc in **back lp** (see *Stitch guide*) of each of next 2 sts, dc in both lps of each st around to first marked sc, working across marked sts, hdc in next st, sc in each of next 7 [9, 11, 13] sts, sk next st, sc in each of next 6 sts, sk next st, sc in each of next 7 [9, 11, 13] sts, hdc in next st, dc in rem **front lps** (see *Stitch Guide*) of each of next 3 sts to overlap beg of row, turn.

Row 2: Ch 2, dc in each of next 2 sts, hdc in next st, [sc in each of next 6 [8, 10, 12] sts, sk next st] twice, sc in each of next 6 [8, 10, 12] sts, hdc in next st, hdc in each st across to back of heel, [dc dec (see *Stitch Guide*) in next 2 sts] 4 times in center 8 sts of heel, dc in each st across, turn.

Row 3: Ch 2, dc in each st across to opposite side, hdc in next hdc, sl st in back lp of each of next 18 [22, 26, 30] sc, hdc in next hdc, dc in each of last 3 sts. Fasten off.

TOE TOP

Rows 2-6 [2-8, 2-10, 2-12]: Ch 1, sc in each st across, turn.

LEFT FOOT (page 10)

SIDES

Row 1: Mark center 24 [28, 32, 36] sc at front of toe, join tan in front lp of sc 3 sts before first marker on left-hand side of Sole, ch 2, dc in front lp of each of next 2 sts, working across marked sts, hdc in next st, sc in each of next 7 [9, 11, 13] sts, sk next st, sc in each of next 6 sts, sk next st, sc in each of next 7 [9, 11, 13] sts, hdc in next st, dc in each rem sc across, dc in back lps of each of next 3 sts to overlap the beg of row, turn.

Row 2: Ch 2, dc in each dc across to back of heel, [dc dec in next 2 sts] 4 times across center 8 sts at heel, dc in each dc across, hdc in next hdc, [sc in each of next 6 [8, 10, 12] sts, sk next st] twice, sc in each of next 6 [8, 10, 12] sts, hdc in next hdc, dc in each of last 3 sts, turn.

Row 3: Ch 2, dc in each of next 2 dc, hdc in next hdc, sl st in back lp of each of next 18 [22, 26, 30] sc, hdc in next hdc, dc in each dc across. Fasten off.
